- 3) ARTS & CRAFTS ONLY... All items must be HANDMADE by the Exhibitor. The Festival Organizer reserve the right to have the Exhibitor remove and article that is not handmade, or is offensive to the public.
- 4) ALL VENDORS AND EXHIBITORS are subject to Federal, Provincial, and Municipal laws while in the Park. Any Festival participants who fail to comply with Local Laws/By-laws will be removed from the Park and NO REFUND will be issued.

*Pets are not permitted in the park during the festival. This applies to patrons, vendors, and exhibitors. Please leave your pets at home or you will be asked to remove them from the park.
